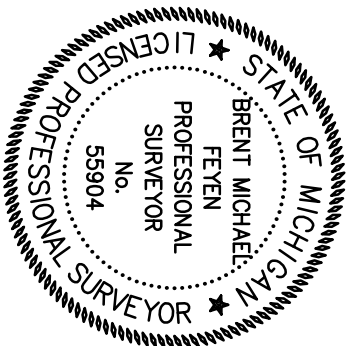


PRELIMINARY

Description as furnished:

That part of the NE 1/4 of Section 33, T8N, R11W, Plainfield Township, Kent County, Michigan, commencing on a line 383.0 feet East of and parallel with the West line of the NE 1/4, 145.94 feet South of the SW corner of Lot 16, Northgate; thence Southwly 278.64 feet parallel with the West line of the NE 1/4 to the North line of Plainfield Avenue (100 feet wide); thence Northwstly 150.52 feet along the North line of Plainfield Avenue; thence Northly 200 feet along a line 122 feet West of and parallel with the West line of Lot 71, Northgate; thence Westwly 128.5 feet to the place of beginning.

Also, that part of the NE 1/4 of Section 33, T8N, R11W, described as: Commencing 121.99 feet West from the NW corner of Lot 71 of Northgate; thence East 121.99 feet; thence South along the West line of said Lot, 126.26 feet; thence West perpendicular to the West line of said Lot, 100 feet; thence South parallel with the West line of said Lot, 206.20 feet to the Northwstly line of Plainfield Avenue, 100 feet wide; thence Southwstly along the Northwstly line of said Avenue, 257.83 feet to a point 126.3 feet from, measuring perpendicular to, extended West line of said Plat; thence North 345.34 feet perpendicular to, extended West line of said Plat; thence North 345.34 feet parallel with the West line of said Lot 72 to beginning.

NOTE: Easements as shown hereon are based on previous surveys by Excel Engineering (841158, dated 8/27/84), Bryan Land Surveys, P.C. (894-1984), dated 4/12/88) and furnished documents.
